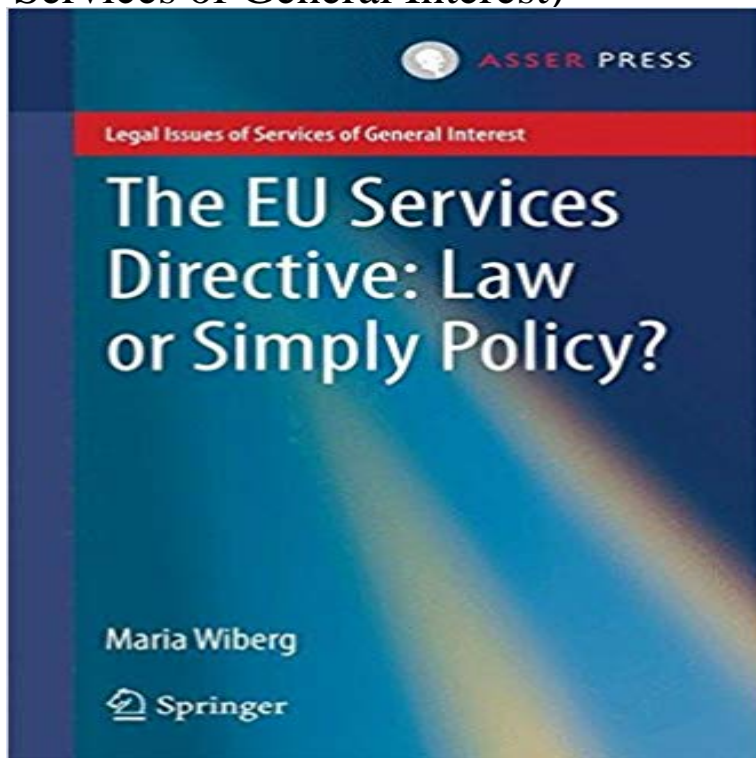


The EU Services Directive: Law or Simply Policy? (Legal Issues of Services of General Interest)
