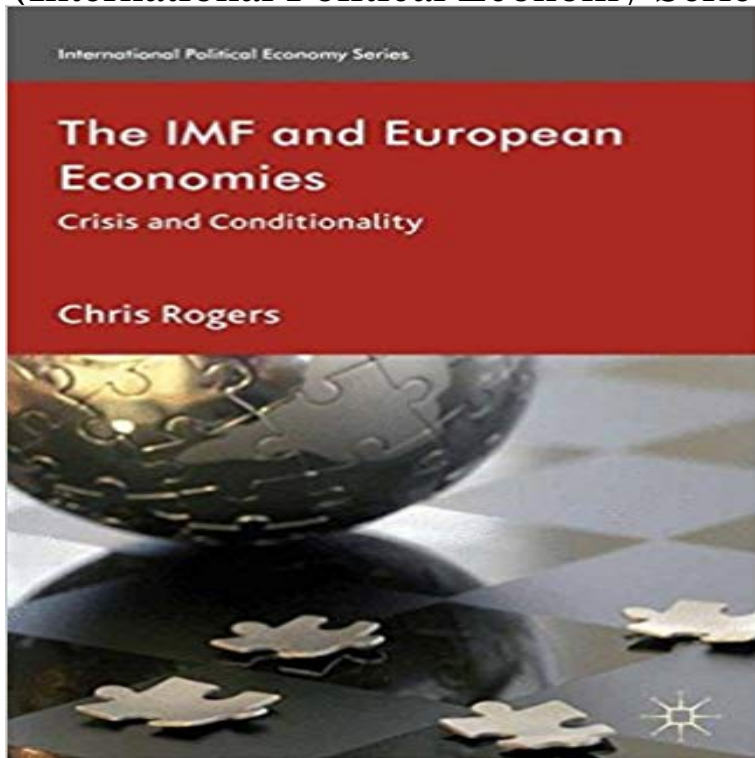


# The IMF and European Economies: Crisis and Conditionality (International Political Economy Series)
