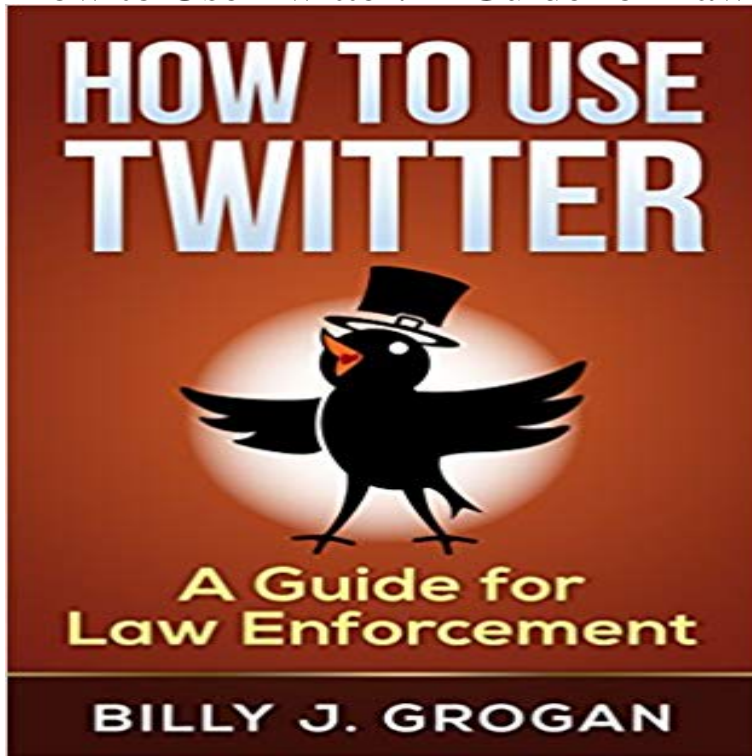


How to Use Twitter: A Guide for Law Enforcement
