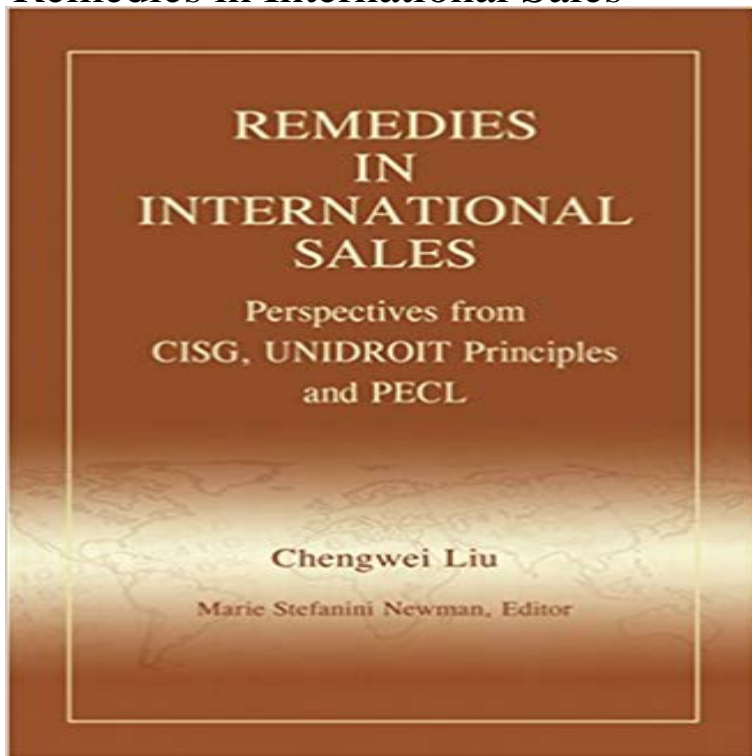


## Remedies in International Sales
