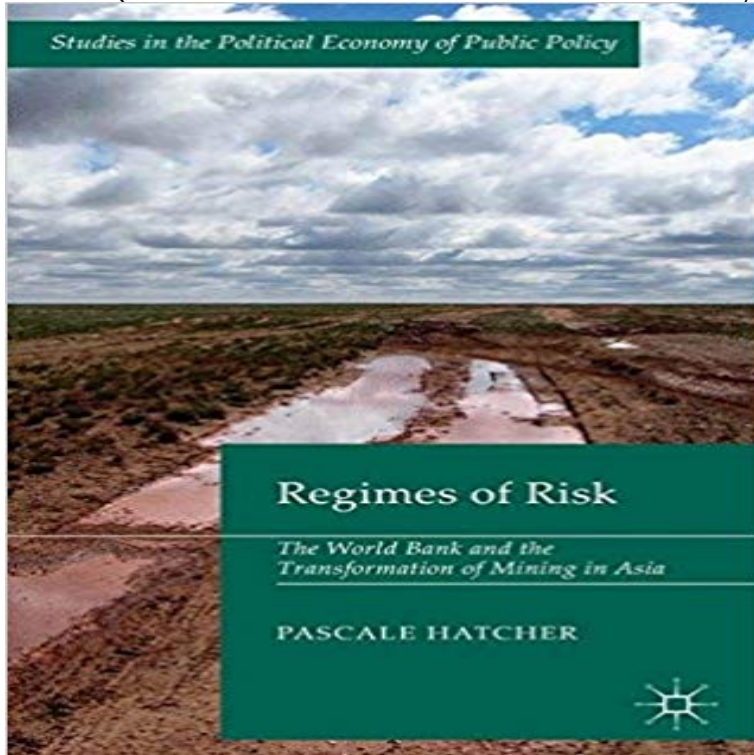


# Regimes of Risk: The World Bank and the Transformation of Mining in Asia (Studies in the Political Economy of Public Policy)
